1. The above vacancies are provisional and subject to variation. The Director, AIIMS, Raebareli reserves the right to vary the vacancies including reserved vacancies as per the Govt. of India rules/circulars and requirements.
2. Reservation will be as per Government of India guidelines issued from time to time.
3. 4% of the total vacancies are horizontally reserved for PwBD candidates with bench mark disability as per the rules. The RPWD Act, 2016/ DOPT instructions as applicable in this regard will be strictly followed.
4. The cut-off date to determine the maximum age limit, essential qualification & experiences will be the last date of submission of application.
5. The period of experience wherever prescribed shall be counted after obtaining the prescribed qualification.

**GENERAL CONDITIONS**

1. The aspiring applicants satisfying the eligibility criteria in all respects can submit their online application form through the link provided in the Institute website [www.aiims.rbl.edu.in](http://www.aiims.rbl.edu.in) on or before **15.12.2023 till 5:00 P.M.**

**Age Relaxation: -**

1. Upper age limit shall be determined as on last date of submission of application.
2. No age relaxation would be available to SC/ST/OBC candidates applying for unreserved vacancies.
3. Age relaxation permissible to various categories is as under: -

Age relaxation to other categories of the candidates will also be applicable as per the DoPT instructions and will be regulated as per the DoPT instructions.

2. Candidates applying under any of the reserved category posts, viz. SC/ST/OBC/ PwBD (OL) will be considered subject of Caste Certificate issued by the appropriate/ competent authority on the prescribed format. Community should be clearly and legibly mentioned in the certificate. OBC candidate's eligibility will be based on the caste(s) borne in the Central List of Government of India. OBC candidate(s) should not belongs to Creamy Layer and their sub-caste should be match with the entries in Central List of OBC, failing which their candidates will not be considered under any of the applied reserved category post(s).
3. **Qualification and Experience:** Qualification and experience as prescribed may be relaxed in exceptional cases at the discretion of the Selection Committee. The experience will be counted as on the last date of application.
4. **Short Listing/Methods of the Selection:** The prescribed qualification is minimum and mere possessing the same does not entitle any candidate to be called for interview or for selection. Based on bio-data, the Screening Committee may short- list candidates for interview. If large numbers of eligible candidates apply for any post, then the Competent Authority may hold a screening test to short-list candidates for interview. Candidates called for interview will have to produce all relevant original documents in proof of details furnished in their application at the time of interview. They may also be asked to submit an affidavit/declaration as decided by AIIMS, Raebareli at time of Interview. The methodology of Selection will be decided by the Selection Committee as deemed fit besides any other matter related to the selection process.

**5. Application Fees:**

A) General/OBC Candidates - Rs.3000/- (Rupees Three Thousand only)

B) SC/ST Candidates/EWS - Rs.2400/- (Rupees Twenty-Four Hundred only)

C) Persons with Disabilities - Exempted

  - ii. Application fee, once remitted, shall not be refunded under any circumstances.
  - iii. Applications without the prescribed fee would not be considered and summarily rejected.
  - iv. Application Fees of SC/ST candidates who appear in the Examination will be refunded (Without GST) after the declaration of results in due course of time.
6. The applicants already in Government service shall have to produce No Objection Certificate from their present employer at the time of Interview. The No Objection Certificate should clearly state that the candidate will be allowed to join if selected and not merely for appearing in the interview.
- 7. AIIMS, Raebareli decision final:**
- The decision of the AIIMS, Raebareli in all matters relating to eligibility, acceptance or rejection of the applications, penalty for false information, mode of selection, conduct of examination(s), allotment of examination centers, selection and allotment of posts/organizations to selected candidates will be final and binding on the candidates and no enquiry / correspondence will be entertained in this regard.

At the time of interview (if called for) the candidate should bring along original certificates in support of his/her age, educational/ professional qualification, experience etc, two recent passport size colour photographs and two sets of self-attested photocopies of the relevant documents failing which he/she will not be allowed to participate in the interview.

- (iii) All the posts carry usual allowances as admissible to Central Government Employees of similar status at AIIMS Raebareli, Uttar Pradesh.
- (iv) **Probation period: The period of probation is two years.**
- (v) The applicants, who do not have requisite qualifications up to the last date for submission of applications, will not be considered.

- (vii) The period of experience wherever prescribed shall be counted after obtaining the prescribed educational qualification.
